FUND DESCRIPTION

Investment Objective: The Horizon Flexible Income ETF seeks current income.

The Flexible Income Fund is an actively managed exchange-traded fund ("ETF") that pursues total return by primarily investing in high-yield fixed-income securities and dynamically adjusting exposures based on market and macroeconomic trends. The Fund combines high income-generating assets, tactical credit allocation, and put spread overlays to enhance return potential and provide risk-managed access to credit markets.

ASPECTS OF THIS ACTIVE FUND

Dynamic: Primarily invests in high-yield fixed income across sectors, with tactical, risk-adjusted adjustments based on market and macroeconomic conditions.

Options-based: Uses put spread strategies to seek risk-adjusted returns.

Risk-Managed: Incorporates a risk timing signal that seeks to manage downside risk and improve the risk-adjusted performance of the credit and option allocations.

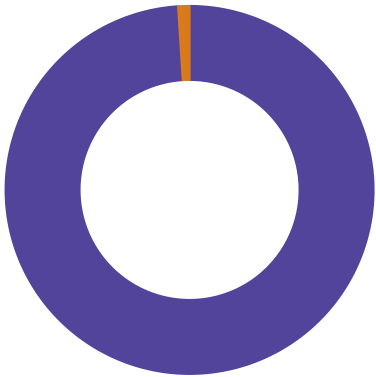

Issuers of floating rate debt are exposed to higher interest payments in a rising rate environment. Issuers may default on interest and principal payments. Generally, securities with lower debt ratings ("junk bonds") have greater credit risk. The Fund's investment in U.S. government obligations may include securities issued or guaranteed as to principal and interest by the U.S. government, or its agencies or instrumentalities.
